2010TechPool -- Revised

In January, the Question Pool Committee (QPC) of the National Conference of Volunteer Examiner Coordinators (NCVEC) released the 2010 Technician (Element 2) Question Pool. Upon further review of the pool, members of the QPC found and corrected more than 50 minor typographical errors and clarified the questions and answers, making them easier to understand.

These adopted changes are now incorporated in a revised question pool. The errata list, as well as the revised Technician question pool, is available on the NCVEC Web site at, http://www.ncvec.org/.

RedCrossMOU

The ARRL Board of Directors has approved a new Memorandum of Understanding between the American Red Cross and ARRL. The new MOU is the result of lengthy negotiations between the two organizations. Being discussed was a Red Cross requirement that Amateur Radio operators who wished to serve as volunteer communicators agree to have an extensive background check performed.

The new MOU allows for amateurs to avoid agreeing to such checking. The new MOU includes an agreement by RC to accept the results of criminal background checks performed by State or local law enforcement agencies as well as checks performed by Mybackgroundcheck.com. From the time negotiations for the new MOU began, the two organizations had agreed that requiring criminal background on volunteer communicators was reasonable. Unfortunately, the only mechanism RC identified for having the checks done was through a service that automatically required the volunteer to agree to multiple forms of checks.

These included manner of living and financial background checks in addition to the needed criminal check. You may recall that RC asserted they would have no more than

criminal checks run on communication volunteers regardless of the wording of the agreement the volunteer was required to sign.

We on the ARRL Board did not believe it was appropriate to accept a new MOU that included such an overly comprehensive

background check agreement. Our goal was to make it possible for individual amateurs to have three options available when considering supporting Red Cross communication. These options were to agree to multiple background checks and to agree only to a criminal background check. The third option, of course, is to choose not to have a background check run and not to be a volunteer. This goal has been accomplished. Hams considering becoming RC volunteers now have the full range of choice.

RC agreement to accept criminal background checks performed by law enforcement agencies came with one provision. The fee will need to be paid by some other agency or by the individual volunteer. This [is} no problem [where] criminal background checks are [done] on behalf of EMA or other civil agency with which the amateur volunteers.

Reciprocal Agreement Holds

From the Hazel Park Zero Beat newsletter regarding operating mobile in Canada

Milt Dzodin N8AYD owns property in Ontario and contacted the Public Relations or Communications Dept. of the Ministry of Transportation. The following replies show that the reciprocal agreement still applies to both sections 13 and section 14 (1) that was added on later. Therefore, this document could be used to prove US hams are exempt from the new cell phone laws in Canada. Some people may want to put a laminated copy in their glove box.

13. (1) Until January 1, 2013, drivers who hold a valid radio operator certificate issued under the *Radiocommunication Act* (Canada) may drive a motor vehicle on a highway while holding or using a two-way radio.

(2) This section is revoked on January 1, 2013. Exemption for pressing buttons 14. (1) A person may drive a motor vehicle on a highway while pressing a button on a hand-held wireless communication device to make, answer or end a cell phone call or to transmit or receive voice communication on a two-way radio if the device is placed securely in or mounted to the motor vehicle so that it does not move while the vehicle is in motion and the driver can see it at a quick glance and easily reach it without adjusting his or her driving position.

(2) A person may drive a motor vehicle on a highway while pressing a button on a device that is worn on his or her head or hung over or placed inside his or her ear or is attached to his or her clothing and is linked to a hand-held wireless communication device to make, answer or end a

cell phone call or to transmit or receive voice communication on a two-way radio or a hand microphone or portable radio.

Leo Tasca has moved to another ministry, so I will be answering your question regarding US amateur radio operators in Canada.

The operation of amateur radio service equipment and stations in the territory of the two countries is covered in Treaty

Series 1952 No. 7 Operation of Certain Radio Equipment or Stations, Convention between Canada and the United States of America. Under the reciprocal Canada-U.S. agreement, Industry Canada treats a U.S. amateur who is operating a radio in Canada with a valid U.S. certificate as having the same privileges as someone who holds a valid radio operator certificate issued under the Radiocommunication Act (Canada).

Under the new Bill 118, amateur radio operators have been granted a three-year exemption for the hand-held use of their radio equipment. After this time, a hands-free operation will be required.

The U.S. amateurs operating in Canada must abide by the *Radiocommunication Regulations* and

Radiocommunication Information Circular 2, Standards for the Operation of Radio Stations in the Amateur Radio Service (RBR-4). A copy of that document is attached. Visiting amateurs are not required to register or receive a permit before operating their amateur radio stations. Each amateur station shall indicate at least once during each contact with another station its geographical location as

nearly as possible by city and state or city and province. The amateur station shall be operated in accordance with the laws and regulations of the country in which the station is temporarily located.

The ban on hand-held wireless communication devices in Bill 118 applies to all road users in Ontario regardless of their home jurisdiction. It is a blanket prohibition with limited exemptions in the legislation, supported by a regulation that grants exemptions to some classes of drivers for certain types of devices. The exemptions are either permanent or time limited.

Section 13 of the regulation grants a time-limited exemption for amateur radio operators licensed by Industry Canada. As noted in my previous email, Industry Canada treats a U.S. amateur who is operating a radio in Canada with a valid U.S. certificate as having the same privileges as someone who holds a valid radio operator certificate issued under the Radiocommunication Act (Canada). A U.S. amateur operator without a valid U.S. certificate, for instance, would not qualify for the exemption.
