

The changes to the repeater power controls, noted last month, are holding up well.

This month's Links:

Accurate, Stable Frequencies - Part 2

Last month's links introduced a project, begun by George (N2APB) and Joe (N2CX), who produce the Chat With The Designers (CWTD) live and recorded podcasts. This project is being presented over three podcasts, with plenty of background at CWTD dot com (cwtd.org)

This series is not just to show how to make a stable frequency source or standard. George and Joe developed some circuit boards that, used with some inexpensive commercial modules, lead one through three stages: 1) a relatively unstable Voltage Controlled Crystal Oscillator (VCXO), 2) upgrading to oven control, and 3) finishing with a very stable frequency source, phase-locked to Geosynchronous Positioning Satellites (GPS). An overview of the project is here.

If one wanted just a very stable frequency source, there is plenty of material on the web for guidance. The CWTD approach is to lead a beginner through the various types of control; voltage, temperature, and phase lock. By building each circuit, testing it, and observing its characteristics, a hobbyist can gain valuable insight in electronic circuits. The CWTD circuits and ancillary commercial modules are:

The basic <u>VCXO</u>
A very inexpensive frequency counter - <u>COUNTER</u>
An oven control circuit - <u>OVEN CONTROL</u>
An inexpensive GPS module - <u>MODULE</u>

The CWTD site has several pages of background for this project. Just take your time, and the structure will take hold. Listening to the associated podcasts will also help.



Amateur Radio Parity Act of 2015

If you've ever attempted to erect an antenna in a subdivision, you may have discovered that homeowners' associations (HOAs) aren't always a ham's best friend. According to findings presented to Congress this year, the explosion in private land usage restrictions is having an increasingly negative impact on the amateur radio service.

An HOA is often focused on protecting the "aesthetics" of a neighborhood, rather than allowing amateur radio operators the ability to erect the antennas so critical to the service. Stories abound of hams building antennas in the attic, or camouflaging them as vent pipes. That works to a degree, but there's no doubt it impedes (pun intended) your ability to get on the air.

In March, Representative Adam Kinzinger (R-IL) introduced HR 1301 "The Amateur Radio Parity Act of 2015" to the House of Representatives. In June, Senator Roger Wicker (R-MS) introduced S 1685 to the Senate. Both seek the same end – to provide the same accommodations within private land use that hams receive today under FCC regulation 97.15(b).

The core of the legislation is below, and is nearly identical for both bills:

SEC. 3. ACCOMMODATION OF AMATEUR SERVICE COMMUNICATIONS.

Not later than 120 days after the date of the enactment of this Act, the Federal Communications Commission shall amend section 97.15(b) of title 47, Code of Federal Regulations, so that such section prohibits application to amateur service communications of any private land use restriction, including a restrictive covenant, that--

- (1) precludes such communications:
- (2) fails to reasonably accommodate such communications; or
- (3) does not constitute the minimum practicable restriction on such communications to accomplish the legitimate purpose of the private entity seeking to enforce such restriction.

Beyond the direct impact to existing amateur radio operators, the proposed legislation cites several other implications. One example is the benefits of amateur radio as a "fertile ground for technical self-training in modern telecommunications, electronics technology, and emergency communications techniques and protocols."

So, what can you do?

ARRL members are urged to contact their members of both the House and Senate, and ask them to sign the bill as a co-sponsor.
